中文摘要:本計畫分析近期中國與台灣在波蘭菁英與一般民眾心中的意象,其目的在促進波蘭社會對中國與台灣意象的了解及此一意象與波蘭對北京和台北政策的關係。本計畫將以建構主義理論為學理基礎並假設由於亞洲國家之公共論述必須執行各種功能,包括啟動,規範或辯護,波蘭社會對中國/台灣之認知與波蘭的中國/台灣政策之間有個互動聯繫。本文依媒體研究和話語分析的論點來進行研究設計,採混合式的研究方法。用於分析的數據來自檢視三份日報和三份週報一年整年的報導內容,以及從半結構化的菁英訪問。研究成果不但有助於對波中關係的理解,並可為波蘭決策者提供實用的知識,而且也有助於中國/台灣對國際關係之認知的相關研究,以及對波蘭媒體對於中國和台灣議題的報導與運用。

英文摘要: This project examines the most recent picture of China and Taiwan among the elites and general public in Poland. The goal is to contribute to the understanding of the image of China and Taiwan in Polish society and the relationship between this image and Warsaw 's policies towards Beijing and Taipei. This study is based on the assumption derived from the constructivist theory, according to which, the picture of China and Taiwan in Polish society and policies towards them are mutually related, since the discourses on the Asian countries perform various functions, including enabling, limiting or justifying. The methods and techniques for analysis are grounded in media research and discourse analysis. The data for analysis comes from the monitoring of the three daily and three weekly papers in the period of one year as well as from the semi-structured elite interviews. This research will not only enrich literature on relations between Poland and China and provide practical knowledge for the Polish decision makers but also contribute to the research on the perception of China in international relations as well as to the understanding of the mechanisms behind the news creation and consumption on China and Taiwan in Polish media.

**Selected fragments - research questions and hypotheses** 

The goal of the analysis of the selected Polish newspapers is to show the ways in which China is represented in certain ways with respect to selected discursive structures with particular consequences for decisions and policies on China – enabling, limiting, justifying, supporting, etc. Within this framework, the research aims to answer the following questions: a) What is the significance and meaning of China promoted by Polish press? b) What topics present in the Western discourse on China are also promoted in Polish press? c) What policies towards China can this particular understanding of China enable, limit, justify or support?

## Chapter 1. Unpacking Taiwan's Exceptionalism: Themes and Studies

## **Selected fragments**

Take a look at the political map of the world and you will see that almost every piece of land belongs to a state. This division, in contrast, for example to the split created by a valley between two mountains, is man-made, imaginary and arbitrary, and therefore can be easily questioned. Indeed, in addition to the multiple disputed borders that permeate the world map, some countries are not recognized or partially recognized. Other states decide whether a certain political unit can be recognized as sovereign. Again, even though their decision concerns imaginary divisions created by borders, accepting or rejecting them has far-reaching consequences in real life. The unrecognized country stays outside of a club of sovereign states, which makes cooperation with its members very difficult or even impossible. It has no choice but to invent novel ways to conduct external relations. Moreover, this specific international situation has a major impact on

its politics, people's lifestyles, culture, etc. This book is about such an exceptional entity in the international community of states – Taiwan.

This research goes beyond the IR framework and analyzes the ways in which Taiwan's international situation has left its footprint on various aspects of the country's development and citizens' lives. It therefore provides a wider, more holistic, and multidisciplinary approach to issues related to the question of Taiwan's sovereignty. The authors of each chapter integrated their studies around the common theme of exceptionalism, carefully curated by the editors.

Chapter 9. Taipei's Soft Power at Work: The Image of Taiwan in Polish Dailies *Gazeta*Wyborcza and Rzeczpospolita

## **Summary**

Taiwan's external relations are "exceptional." Due to the island's contested international status and limited recognition, public diplomacy often provides Taipei with the only channel to conduct external affairs through the soft-power resources it enables. Therefore, in order to assess the island's foreign policies, it is crucial to understand its soft power capacity.

This chapter analyzes the challenges to the exercise of Taiwan's soft power as well as its effects in selected Polish dailies. First, it looks for themes that may enable and disable Taiwan's soft

power in the scholarly literature and documents released by Taipei's governmental actors. Second, it examines whether these themes pertaining to the island were present in two Polish dailies – *Gazeta Wyborcza* and *Rzeczpospolita* – during a one-year period from November 1, 2016 to October 31, 2017. The newspaper analysis aims to reveal narratives that are alternative to those promoted publicly and that are related to the image of Taiwan, other significant international actors, and Taiwanese governmental as well as non-state executors of public policy, all of which may contribute to an enabling or disabling environment for Taipei's soft power. It applies techniques and methods from media research and discourse analysis.

## 前言

誰沒有聽過「中國威脅」(China Threat)?

儘管此一概念在西方世界已經存在了一個多世紀,但由於學術界、政界和記者們的頻繁使用, 這句話才在冷戰之後廣泛地為大眾所熟知。」近期以來,「中國崛起」被視為是在各個面向對 於全世界的國家與人民是威脅,包括在經濟、安全、生活方式、福祉、環境等層面。至於「中 國威脅」如今不僅成為媒體以及新聞從業人員間熱烈討論的話題,而且也在國際關係研究學界 中成為話題焦點。學者們不僅試圖分析「中國威脅」這個詞語之背後原因與本質,也聚焦其後

果以及應對方式。關於「西方」對中國看法之論述雖已汗牛充棟,但主要還是指美國的觀點,其他國家的社會態度目前仍有待分析。由於不同的歷史經驗、與中國關係以及區域、國家利益等,世界其他國家的人不一定要跟美國對中國的看法相同。

這篇短文主要在探討對波蘭人而言,崛起的中國是否為一種威脅,如果是的話,主要又針對哪些方面。雖然北京並不算是華沙重要的政治夥伴,華沙在這方面與歐盟(EU)和美國的關係反而較為密切,但近年來中國與波蘭兩國首都之間的接觸,確實由於經濟因素而大大增加。其中,包括中國市場為外國企業和投資者提供越來越多的經濟機會,而且中國在「一帶一路」和推動與中東歐 16 國合作的「16+1」倡議框架內增加了該地區的活動,例如相關投資、基礎設施和交通項目。問題在於,波蘭與中國之間關係的這些新發展是否與美國所謂的「威脅」有關,或者他們的看法其實不同。本文之目的並非確定中國是否真的對波蘭有威脅,而是要探討「中國威脅」在特定之波蘭報紙上的論述,因為這些報紙在現實生活中可能會對波蘭政府以及社會在政治、金融、經濟和安全的相關決策上產生影響。

#### **Abstract**

This work enters into the long-standing debate on the meaning of "sinology." It takes as a springboard theoretical assumptions regarding the term's floating meaning, which, due to the shifting nature of disciplinary boundaries in which all knowledge is relative, can never be fixed. It looks at the University of Warsaw's (UW) Sinology Department and asks what Polish academia counts as discipline- specific knowledge. In order to answer that question, it analyzes the rhetorical work involved in defining and defending the discipline in selected works by and

interviews with Polish scholars who study China. It comments on the phenomenon of creating disciplinary labels, the role of external pressures on knowledge production, and the ways in which the UW Sinology Department's faculty mediates and assimilates those pressures.

## IV. PROBLEMS ENCOUNTERED AND THEIR SOLUTIONS

Prolongation of the grant

Originally, I received this grant for two years starting from 1 September 2016 till 31 July 2018. However, in November 2017, I gave birth and took a year maternity leave during which I was not able to work on this research. Therefore, in order to cover the time taken for family reasons, I postponed the realization of the grant for one year, till 31 July 2019.

## Data collection

According to the original research plan, I have started collecting the articles from the three daily and two weekly newspapers on 1<sup>st</sup> November. After the two months of data gathering, in January, I decided to resign from the analysis of the one of the dailies – *Fakt Gazeta Codzienna*, as the word 'China' has not appeared in it for the two months, except one mention of the Chinese team participation in the sport event. Therefore, I limited my data to the two daily (*Gazeta Wyborcza* and *Rzeczpospolita*) and three monthly (*Newsweek Polska, Polityka and Wprost*).

Moreover, as the number of articles in dailies, which met the selection criteria in the first two months of analysis turned to be very large, I decided to code the newspaper issues every other week, instead of every week.

Additionally, by the time when I started newspaper analysis, the Polish market for newspapers had changed with respect to the situation from the year when the research project was designed. In general, the right-wing titles, which originally enjoyed relatively low readership, became more popular and greatly increased audience. In order to adjust to this change and to cover all the voices represented in newspapers, I increased the number of analyzed newspapers and examined a new research question concerning the comparison of the picture of China and Taiwan between the titles representing different political orientations.
